OVERVIEW



HOST CITY MONTERIA CORDOBA COLOMBIA: Montería, the capital city of the Department of Córdoba, is located in the northwestern part of the country, within Colombia's Caribbean region. Situated on the banks of the Sinú River—hence its nickname "Pearl of the Sinú"—it is also known as the "Cattle Capital of Colombia." The city has a total population of 527,436 inhabitants and an average temperature ranging from 28°C to 32°C.

Montería is a cultural city recognized for its traditional folk dances such as cumbia, porro, and fandango, as well as for its handicrafts made from natural fibers, such as the iconic sombrero vueltiao. It is home to major national events such as the corralejas and the National Cattle Fair, both of significant importance in Colombia.

PARTICIPANTS' DECLARATION

General Regulations – Art. 29 When submitting their registration, participants in the JEDECAC shall sign the following declaration: "I hereby declare, on my honor, that I will respect the Statutes of CONCECADE, the General Regulations of the Central American and Caribbean School Sports Games, the Competition Rules, and all other provisions of the Games, committing myself to participate under the principles of Fair Play, applying my utmost effort and technical skills."

TECHNICAL INFORMATION MEETING: November 1

REGULATIONS: The JEDECAC General Regulations will apply, as well as the current WA (World Athletics)

rules.

CATEGORY:

Athletes' ages must comply with Article 28 of the JEDECAC General Regulations. The upper age limit is 17 years (U-18) as of the competition year, with no lower age limit established, since this is a non-contact sport.

- ❖ In athletics, each country may register up to two (2) athletes per event, with each athlete allowed to participate in a maximum of three (3) events in total (including individual and relay events). This is subject to not exceeding the established maximum number of participants.
- For an event to be official and count towards the medal tally, at least 3 athletes from different countries must be registered in that event.
- Each country may register one (1) coach for every ten (10) athletes registered; if registering fewer than 10 athletes, the country may register one (1) coach.
- Once the nominal registration has been completed, no new athletes may be added during the Technical Meeting. This meeting is intended to confirm and/or correct any registration details according to the organizational and technical circumstances of each country.

COMPETITION SYSTEM AND TECHNICAL SPECIFICATIONS

Track Events:

The formation of heats for sprint events will be conducted as established by the regulations. Groups will be automatically generated by the event's technical secretariat based on the times submitted in the nominal registration (Rule 166, former IAAF). For the final race, the top four (4) semifinal qualifiers will be randomly assigned lanes 3, 4, 5, and 6, while the remaining four (4) qualifiers will be randomly assigned lanes 1, 2, 7, and 8. The first three (3) athletes in each semifinal heat plus the next two (2) fastest overall times will qualify for the final.

For events longer than 800 meters, final races will be conducted based on times (timed finals).

Field Events:

In the qualifying rounds, seeding will be done automatically based on the recorded marks. The final round will proceed according to the regulations.

High jump and pole vault events will be conducted as direct finals.

AWARDS:

Medals will be awarded for each tournament, modality, and event as follows:

1st place – Gold medal

2nd place - Silver medal

3rd place - Bronze medal

PROTESTS AND CLAIMS:

Article 39: Eligibility (based on age or affiliation to educational institutions). Protests regarding an athlete's eligibility before the start of the Games will be resolved by the JEDECAC Technical Committee for the respective sport. Protests must be signed by the Head of Mission, Deputy Head of Mission, or the respective Sports Delegate. To confirm athlete eligibility, delegations must present original passports during technical meetings. All Heads of Mission will have access to these documents.

TECHNICAL GUIDELINES ATHLETICS

Article 40. The Organizing Committee (OC) and the Technical Commission of CONCECADE (Central American and Caribbean Sports Council) will appoint a First Instance Appeals Tribunal for each sport, responsible for hearing and resolving protests and claims within their respective sport discipline.

This Tribunal will be composed of three (3) people: the technical coordinator of the sport discipline and two representatives from participating countries elected during the technical information meeting.

TRANSITORY PROVISIONS:

Any matters not covered in this document will be resolved by the JEDECAC Organizing Technical Committee.
